Water Street Mission (WSM) is a faith based organization that seeks to address aspects of poverty beyond just homelessness and works to create healing communities where lives are transformed.

Purpose Statement

To advance the kingdom of God through the gospel of Jesus Christ and to do missionary, relief, and rescue work of all kinds.

Statement of Faith

Background and Interest

Consent, Release, & Confidentiality

- 1. I hereby give my full consent and permission to Water Street Mission (WSM) to obtain information relating to my criminal history and any other applicable records. I understand that this information will be used in part to determine my eligibility for a volunteer position within this organization. I also understand that as long as I remain in such capacity here, the above mentioned record checks may be repeated at any time. I understand that I can request to view the results of these checks. I, the undersigned, do for hereby remise, release, and forever discharge and agree to indemnify Water Street Ministries, each of their officers, directors, employees, volunteers and agents, and references and other persons who furnish information about my record and character and hold them harmless from and against any and all causes and actions, including but not limited to: suits, liabilities, costs, debts, and sums of money, claims, and demands whatsoever and any and all related attorney's fees, court costs, and other expenses resulting from the investigation of my background in connection with my application to serve.
- 2. I agree that if I am arrested or convicted of an offense that would constitute grounds for denial of volunteer work, or named as a perpetrator in a founded or indicated report of abuse I will notify WSM in writing within 72 hours.
- 3. I understand that if my actions are contrary to the policies and volunteer expectations of WSM, I may be subject to possible dismissal from volunteer duties.
- 4. I have read and understand the purpose statement and Statement of Faith of Water Street Ministries. I agree that while volunteering at WSM, I will operate in a manner that is consistent with their purpose statement and statement of faith.
- 5. While performing duties as a volunteer of WSM and after my service is completed, I understand that ensuring the confidentiality of donor and guest records is of the highest priority. I agree to keep secure, and not to misuse or disclose any guest or donor information to which I have access, without proper informed and voluntary guest or donor consent.
- 6. I understand there are certain situations exempt from confidentiality. I agree that I have read these exemptions and I agree to talk to my field instructor or task supervisor should I have questions about confidentiality issues:
 - Contact of legal guardian of a youth who is under 18 years of age
 - Contact of the police for any guest who has an outstanding warrant
 - Notification of child protective services in the cases of suspected abuse or neglect
 - Contact of the police and/or mental health crisis intervention in cases where there is reason to suspect that a client may be at risk of hurting themselves or others
 - Contact of medical professionals in cases of serious injury or life threatening conditions where a guest is unable to speak for themselves
- 7. I agree that upon the conclusion of my volunteer services from Water Street Mission, I will return my ID badge and all documents and property of Water Street Mission I obtained during the course of my volunteer service. I further agree that I shall not retain copies or notes of the foregoing.
