RESULTING UNMET EMOTIONAL NEEDS CAN LEAD TO UNHEALTHY RELATIONSHIPS AND SELF-DESTRUCTIVE BEHAVIORS THAT DETERIORATE ONE'S ABILITY TO SUSTAINABLY CARE FOR THEMSELVES AND THEIR DEPENDENTS.

CONVENTIONAL METHODS OF DEALING WITH HOMELESSNESS OFTEN FOCUS ON TRIGGER EVENTS OR PRESENTING SYMPTOMS, SUCH AS SOCIAL JUSTICE AND THE LACK OF HOUSING ITSELF, BUT WITHOUT ADDRESSING THE ROOT ISSUES, THEY WILL NEVER RESULT IN TRUE RESTORATION OR AN END TO THE CYCLE OF HOMELESSNESS FOR INDIVIDUALS AND THEIR FAMILIES.

THEREFORE, WITH A SPIRIT OF LOVE, DIGNITY, AND GRACE, WE PROVIDE AN

ENVIRONMENT OF HOPE AND HEALING TO AWAKEN INDIVIDUALS TO THEIR TRUE IDENTITY IN CHRIST. OVERTIME, WE SEE THAT AS GUESTS EXPERIENCE THIS LOVE, DEFENSES COME DOWN, AND HEARTS ARE OPENED TO CHOOSE A BETTER PATH. OVER HALF OF OUR GUESTS CHOOSE TO ENGAGE ON A DEEPER LEVEL WITH THEIR OWN UNIQUE ROOT ISSUES AND THE SPIRITUAL CORE OF THEIR TRUE IDENTITIES IN CHRIST.

WITH THEIR WATER STREET LIFE COACH WALKING ALONGSIDE THEM, OUR GUESTS ARE EMPOWERED TO WORK ON THE ADDITIONAL 7 DIMENSIONS OF HEALTH - TO BUILD NEW SKILLS AND DEAL WITH UNIQUE INDIVIDUAL CHALLENGES THAT COULD OTHERWISE PREVENT THEM FROM SUCCESSFULLY ESTABLISHING THEIR NEW LIFE.

WE LOVE AND PROVIDE FOR THE PHYSICAL NEEDS OF ALL WHO COME TO THE MISSION. GUESTS WHO CHOOSE TO WORK THROUGH THEIR ROOT ISSUES, PUT THEMSELVES IN A POSITION WHERE GOD CAN NOT ONLY RESTORE THEM, BUT EQUIP THEM TO BE RESTORERS OF OTHERS AS WELL (BASED ON ISAIAH 61).

THIS YEAR, OUR PROGRAMS HAVE BEEN ADAPTED IN ORDER TO ENSURE THE SAFETY OF OUR GUESTS. COUNSELING VIA VIDEO CALLS. WHILE MUCH OF OUR WORK COULD BE DONE FROM A DISTANCE, AS AN ESSENTIAL BUSINESS OUR ONGOING WORK IN PROVIDING FOOD, SAFE AND MONITORED SHELTER CONTINUED DAY-IN AND DAY-OUT.

WE ALSO ADAPTED OUR FOOD OUTREACH PROGRAM OVER THE COURSE OF THE PANDEMIC. EACH WEEK, GROCERIES ARE GIVEN TO MEMBERS OF OUR COMMUNITY WHO ARE STRUGGLING WITH FOOD INSECURITY THROUGH OUR OUTREACH CENTER. TYPICALLY GUESTS COME THROUGH A SHOPPING EXPERIENCE DESIGNED TO UPHOLD DIGNITY AND GIVE GUESTS AUTONOMY OVER THEIR CHOICES. HOWEVER, OVER THE LAST YEAR WE BEGAN TO GIVE OUT BOXED FOOD DONATIONS TO REDUCE COVID-19 EXPOSURE OF OUR GUESTS AND STAFF. NO MATTER WHAT, OUR GOAL IS TO BUILD A LOVING COMMUNITY, WHERE EACH PERSON WHO COMES TO US FOR FOOD AID, LEAVES FEELING THEY ARE VALUED, AND AN IMPORTANT CHILD OF GOD.

LINE 4B - TEEN HAVEN IS A MINISTRY SERVING THE YOUTH OF THE CITY OF LANCASTER, PA. THIS MINISTRY IS DONE THROUGH PROVIDING A VARIETY OF PROGRAMS AND SERVICES OUT OF OUR NEIGHBORHOOD BASED YOUTH CENTER, AND THROUGH PARTNERSHIPS WITH LOCAL CHURCHES.
